As per the UGC regulations now onwards Ph.D. Programme shall be for a minimum duration of 3 (Three) years including course work and a maximum duration of 6 (Six) years from the date of admission to Ph.D. Programme.

Important Instruction

- ❖ **Eligibility Criteria:** Master's Degree in the concerned subject from a recognized university with minimum 55% marks.
- ❖ **The admission process consists of Two phase**
 1. Written test of TWO hours duration with 100 MCQ Question comprising of 25 MCQ for Research Methodology, 25 MCQ for General knowledge and 50 MCQ for Speciality Subject.
 2. Personal interview and brief presentation about proposed research topic.
- ❖ The selection will be made purely on merit basis of marks secured in MAM University's PhD Entrance Examination and personal Interview.
- ❖ Candidates seeking admission in Ph.D. are required to appear in the offline Entrance Test to be conducted on 11/12/2022.
- ❖ The Schedule for Personal Interview will be intimated to the candidates and interview will be held offline.
- ❖ The result of entrance test will be declared after the personal interviews.
- ❖ Finalization of the speciality and seats are subject to availability of guide at the time of counselling.

- ❖ Candidate is supposed to submit self-attested copies of S.S.C., H.S.C., B.A.M.S. /M.D. / M.S. (Ayu) at the time of counseling.
- ❖ The schedule of commencement of course work and classes will be notified at the time of declaration of the result at the end of final selection process.
- ❖ The candidates are advised to check their eligibility before applying for the test.
- ❖ The clearance of entrance test does not entitle a candidate for admission. The admission will be finalized on the basis of the final merit list to be prepared after the conduct of personal interview and Checking of original documents of the candidate.
- ❖ As per the UGC regulations 2022, **Ph.D. through Part-time Mode** will be permitted, provided all the conditions stipulated in UGC regulations are fulfilled. Candidate has to obtain a “No Objection Certificate” from the appropriate authority in the organisation where he/she is employed, clearly stating that:
 1. The candidate is permitted to pursue studies on a part –time basis.
 2. His/her official duties permit him/her to devote sufficient time for research.
 3. If required, he/she will be relieved from the duty to complete the course work.
- ❖ Scholars appearing in their Post-Graduation Final Year Examination can also apply, however their admission will be subjected to the result of final examination declared before the date of counseling.
- ❖ No stipend will be given to the Ph.D. Scholars.
- ❖ Candidate has to sign and submit the bond of Rs 3 Lakh to ensure the completion of program at the time of joining.
- ❖ Annual fee for PhD will be RS 1,20,000/- (one lakh twenty thousand).
- ❖ If two candidates of the same category get equal marks in entrance test, their total marks of final year BAMS theory exam will be considered for merit place. In case where the total of final year BAMS marks are also found equal, total marks of the 12th standard will be considered to decide merit.
