Instructions to Participants :

- The Paper Should not have been presented or published before anywhere.
- Code of sub theme should be mentioned on right corner of the title page of paper.
- Title page should contain Title of paper, full name of authors with designation, Institute's name, postal address, Email ID, and contact number.
- Paper must be in IMRaD format.
- Case study and case series must be as per the CARE criteria. Title should include case study/case report/case series. In case study and Case series there should be follow up of the case/s. In case study don't include the section of conclusion.
- Referencing must be according to Vancouver style of referencing.
- Tables, charts, diagrams and images should be in the end after references.
- Do not add references in the footer. Give appropriate numbers in the text for the references (in the superscript).
- Spelling must be according to American English.
- No decoration in the article is accepted. It should be computer typed (MS word) on A-4 sized paper, not exceeding 5-6 pages.
- It must be either in English or Hindi (Google input font). Please don't mix two languages in one sentence, and in one paragraph.
- *Ślokā*, if any, may be typed in Google input font, and give the complete references. (Google input font is placed in the website for ready reference).
- Abstract and incomplete papers will not be accepted.
- Authors need to send a hard copy of full paper with signature on each page along with a certificate.
- Registration details should be sent through Google form.
- Paper should be sent by email in MS word to email ID- rsbknadiad@gmail.com
- Selected papers will be considered for oral or poster presentation.
- Instructions for poster presentation will be communicated separately to the concerned.
